Santa makes a special visit, there is entertainment, and foods and beverages to keep your customers smiling. The Fair is promoted through radio, television, newspaper and fliers throughout Utah and Colorado.

Eligibility The Holiday Arts & Crafts Fair encourages applications for the display and sale of handcrafted goods, i.e. candles, soaps, baskets, paintings, prints, photography, ceramics, textiles, sculpture, jewelry, glass work, wood work, metal work, and baked goods. We encourage work that is original to the crafts person in concept, design and creation. Please submit photographs of your work with your application (the photos will be returned during the event). *No manufactured or imported goods will be allowed.* Items not honestly represented on applications may be removed. If you have questions as to whether your work qualifies, please call (435) 259-6272.

Your application must be postmarked no later than November 13th, 2009. Include your application, a check, a self-addressed and stamped envelope (SASE) along with three (3) photographs of the items you will be selling. A temporary sales tax license will be issued at no cost at the beginning of the show. The tax rate in Moab is 7.75%. You are responsible for reporting sales from this show to the Utah State Tax Commission.

Booth Space Booths are approximately 8' X 8' and located inside the Moab Arts & Recreation Center. The rooms are large with high ceilings and arched windows that allow plenty of natural light. Two applicants may share a booth. Tables, chairs, and access to electricity are available upon request at no charge. In addition to the 8' X 8' spaces, there are two spaces 8' X 6' on the landing just outside the two main rooms on the upstairs level. Several mini-booths equipped with 4' X 2' tables are also available. Smaller card table locations are available for local vendors only. Each exhibitor must provide his or her own display, equipment and lighting. Exhibitors are responsible for attending their booths.

Assignment of booths will be at the discretion of the Holiday Arts & Crafts Fair. Booth setup is Friday, December 4th from 5 p.m. to 8 p.m. and Saturday, December 5th from 7:00 a.m. to 9:30 a.m. Booths may remain overnight, however security is not provided. The MARC is not responsible for damage, theft, loss of arts, crafts or display materials. Tear down begins at 5 p.m. on Saturday and exhibitors are expected to keep their booths open until then.
